



Daycare / Boarding Agreement & Release

_____ 1. In consideration of being permitted to use the services and facilities of Club, K-9, Inc., I/we, the undersigned owner(s), hereby release, waive and discharge Club K-9, Inc., its shareholders, staff, sub-contractors and volunteers from all liability for any and all loss or damage, and any claim or damages resulting there from, on account of injury, loss, damage, ailment or disease to my/our dog(s), even resulting in death, while my/our dog(s) is/are under the care of Club K-9, Inc.

_____ 2. I/we agree to indemnify Club K-9, Inc., its shareholders, staff, sub-contractors and volunteers for any loss, liability, damage or cost they may incur due to my/our presence or the presence of my/our dog(s) in or upon Club K-9, Inc.'s premises and while my/our dog(s) is/are under the care of Club K-9, Inc.

_____ 3. I/we hereby assume full responsibility for any harm or damage caused by my/our dog(s) while in or upon Club K-9, Inc.'s premises and while my/our dog(s) is/are under the care of Club K-9, Inc. I/we further agree to indemnify Club K-9, Inc., its shareholders, staff, sub-contractors and volunteers for any loss, liability, damage or cost they may incur due to any harm caused by my/our dog(s).

_____ 4. I/we expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the State of Oregon, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

_____ 5. I/we further understand and agree that in admitting my/our dog(s) to Club K-9, Inc., the operators of Club K-9, Inc. have relied on my/our representation that my/our dog(s) is/are in good health and has/have not harmed or shown aggression or threatening behavior toward any person or any other dog.

_____ 6. I/we further understand that any problem, including but not limited to injury and illness, that develops with my/our dog(s) will be treated as deemed best by the staff of Club K-9, Inc., in their sole discretion, and that I/we assume full financial responsibility for any and all expenses involved, and that I/we hereby agree to indemnify Club K-9, Inc., its shareholders, staff, sub-contractors and volunteers for any expenses incurred for such treatment.

_____ 7. I/we understand that all fees are non-refundable for any reason.

_____ 8. I/we have read and understand the attached Rules and Regulations and Cancellation Policy and agree to abide by them.

Rules and Regulations

_____ 1. All dogs must be dog-friendly and people-friendly. They must be non-aggressive and non-protective of food and toys. If we determine at any time that a dog's behavior is aggressive, we reserve the right to dismiss him/her from daycare/boarding at our own discretion.

_____ 2. If your dog eliminates on the grounds outside of Club K-9, please clean up and deposit in the appropriate receptacles.

_____ 3. All dogs must arrive and leave on a leash and wearing a flat, leather or nylon, quick-release collar with tags. Club K-9 personnel may remove the collar for safety reasons.

_____ 4. All dogs must be in good health, spayed or neutered, physically sound and adequately protected from disease. Any dogs receiving a Bordatella Inter-nasal immunization may not come to Club K-9 for the following week and if symptomatic until all symptoms subside.

_____ 5. All dogs must be relatively clean, brushed, and flea free.

_____ 6. Business hours are 7:00 a.m. to 6:00 p.m. Monday thru Friday and 10:00 a.m. to 4:00p.m. on Saturdays & Sundays. All dogs must be picked up during business hours. There is a, one time, 15-minute grace period, after which time a late fee of \$1.00 per minute will be charged. With advanced notice Club K-9, Inc. may allow for early drop-off or late pick up at a rate of \$5.00 per hour per dog.

_____ 7. All dogs must arrive for daycare and for boarding no later than 10:00a.m. Monday thru Friday, and between 10:00 and 11:00a.m. on Saturdays & Sundays. Dogs arriving late will be turned away and will be considered out of compliance with our Cancellation Policy. If late drop-off is required special arrangements may be made in advance.

Cancellation Policy

1. _____ Cancellations to any portion of a boarding reservation during non-peak times must be made no later than 48 hours in advance of arrival date. Cancellations made with less than a 48-hour notice will incur a charge equal to the amount of a two-night stay. If more than one type of room is reserved the charge will be for the more expensive room. If the reservation is only for one night the charge will only be for one night.
2. _____ A seven day notice will apply for cancellations made for all reservations during peak times and for all extended stays. Any cancellation or alteration of a reservation must be made seven days in advance of the arrival date. When the seven day notice applies any cancellation made with less than seven days notice will incur a charge equal to the amount of the seven night stay. If fewer than seven nights are reserved then the charge will be for the number of nights reserved.
3. _____ Peak times include, but are not limited to, all reservations that include a holiday, holiday weekend, spring break, and the months of November, December, & January. I understand that it is my responsibility to verify if my reservation is during a peak time when I make it.
4. _____ A seven day notice will always apply to extended stays. An extended stay is any reservation that is for more than seven nights.
5. _____ Cancellations to daycare reservations must be made by the end of business day the day before arrival. All daycare days must be paid for in advance and without adequate cancellation the daycare day will be forfeited.
6. _____ I agree to provide my credit card information when making all reservations that I have not paid for in advance. I understand that Club K-9, Inc. will charge my credit card if I do not cancel my reservation with adequate notice.
7. _____ In addition, I understand that my credit card will only be charged if I do not cancel my reservation with adequate notice. Otherwise, the credit card information will only be used to hold the reservation. I must bring whatever form of payment I would like to use when I drop-off my dog.
